Sergeant David Enzbrenner was shot and killed in an unprovoked attack while assisting a code enforcement officer serve a nuisance order at a home near the intersection of 12th. and Division Streets shortly after 4:00 pm.

A person unrelated to the order suddenly approached and opened fire without warning, killing Sergeant Enzbrenner. The man then committed suicide. It is believed the man held a grudge against law enforcement officers because his father was serving a life sentence without parole in Louisiana.

Sergeant Enzbrenner had served with the Atchison Police Department for 24 years. He is survived by his wife and three children.

Use of Criminal Justice Data

The following should be considered when using the data contained in this publication:

- The data contained herein is only from agencies that submit incident based data to the Kansas Bureau of Investigation. It does not include some of the larger agencies in the state that submit summary data.
- This data should be viewed as a snapshot of crime in Kansas. These numbers constantly change as some crimes are not reported until years later. The data contained in this publication reflects reports in our system on 10/1/2012.
- Due to staffing and budgetary constraints, November and December data for 2009 is incomplete. Most violent, sexual and domestic violence crimes were entered but many property crimes were not. This may account for a decline in some crimes at the end of 2009.
- Person crimes (Murder, rape, aggravated assault) are scored as one offense for each victim. Property crimes (burglary, larceny, robbery and arsons) are scored as one offense for each incident.
- When discussing arrest data there is a difference between persons arrested and incidents cleared by an arrest. For clearance purposes, only one arrest is counted for each incident.
- Property value data reported with burglary offenses are also included in data reported for theft/larceny offenses.
- When more than one type of theft occur within an incident, the type which incurred the highest dollar loss is reported and all property stolen included.

History of Kansas Incident Based Reporting

The collection of crime data in Kansas began in the mid-1970's after legislation was passed (Kansas State Statutes 21-2501a and 21-2504) authorizing the Attorney General to collect information necessary to determine the true condition of crime in Kansas. The Attorney General assigned the Kansas Bureau of Investigation (KBI) to establish a statewide program for the collection of Uniform Crime Reporting (UCR) data for submission to the Federal Bureau of Investigation (FBI). Subsequent activities resulted in nearly 100% coverage of the state and timely reporting to the FBI's UCR Program by 1978.

In 1982, the KBI, with the aid of a local law enforcement user's group, began to study the usefulness of establishing an Incident Based Reporting (IBR) system in Kansas. As a result, in 1986, the first Kansas Incident Based Reporting System (KIBRS) was implemented to collect relevant information on the occurrence and composition of crime in Kansas. Pursuant to state statute, law enforcement agencies at state and local levels began reporting standardized data on criminal offenses in their respective jurisdictions using a format approved by the Attorney General. The state program then converted the data to UCR format for submission to the FBI.

Throughout its first 60 years of operation, the FBI's UCR Program remained virtually unchanged in terms of the data collected and disseminated. As time progressed a broad utility evolved for UCR data. This allowed law enforcement to expand its capabilities to supply crime information. In the late-1970's, the law enforcement community called for a thorough evaluative study of UCR with the objective of recommending an expanded and enhanced UCR program to meet law enforcement needs into the 21st century. The result was the implementation, in 1988, of the National Incident Based Reporting System (NIBRS).

In 1991, the KBI, with the aid of a second local law enforcement user's group, began a comparative study of KIBRS against NIBRS. As a result, in 1993 the KBI implemented a new KIBRS program meeting the requirements of NIBRS. This resulted in new standardized forms and created formats for reporting data to the KBI electronically.

With the arrival of incident based reporting, offense and arrest reports are now being used for much more than annual statistics. The expansion of data fields that are collected will assist Kansas in moving into the future by using these reports to assist in criminal investigations. In addition, IBR data will offer:

- (1) More detailed, accurate, and meaningful data than produced by the traditional summary UCR Program;
- (2) Common denominator links among agencies both statewide and nationally;
- (3) Extensive, specific crime information concerning similar jurisdictions, allowing the identification of common crime problems or trends;
- (4) Statistics to enable law enforcement agencies to supply a better accounting of their activities to their governing bodies;
- (5) Legislators, municipal planners / administrators, academicians, penologists, sociologists, and the general public the ability to better assess the state's crime problems using the extensive data supplied through KIBRS;
- (6) Availability of KIBRS data through the Kansas Criminal Justice Information System (KCJIS) web-server.
- (7) Information necessary to acquire funding from grants to combat crime for a law enforcement agency.
- (8) Development of investigative tools to assist law enforcement agencies as they examine cases, leads and other investigations. KIBRS Views and the FBI's National Data Exchange (N-DEX) are two examples of this type of tool.



RATE OF INDEX CRIME

Index crimes totaled 72,702 offenses for 2011, consisting of 31 offenses per 1,000 population. This represents a two-point drop from those reported in 2010.

LARGEST CATEGORY OF INDEX CRIMES

The largest number of offenses reported in 2011 were for larceny (theft) with 46,876 offenses. Property loss for these offenses were valued at \$39,323,860. The number of thefts reported increased 1.1% from 2010, with a 33.1% increase in dollar loss.

VIOLENT CRIMES

There were 7,932 violent crimes (murder, rape, robbery, and aggravated assault/battery) reported in 2011. This decreased 6.0% from 2010.

NON-VIOLENT CRIMES

There were 64,770 non-violent crimes (burglary, larceny, and motor vehicle theft) reported in 2011. This increased 0.7% since 2010.

VALUE OF STOLEN PROPERTY

Stolen property was valued at \$66,230,128 in 2011; of that amount 30.4% were recovered. The dollar loss increased by \$13,170,427 or 24.8% compared to 2010.

MURDERS

A total of 63 murders were reported in 2011, up 5.0% from 2010

LAW ENFORCEMENT OFFICERS KILLED OR ASSAULTED

One officer was killed in 2011 as the result of a felonious act.

No officers were killed in 2011 as the result of an accident or negligent act.

Nine hundred seven (907) law enforcement officers were assaulted in 2011. This represents a decrease of 10.2% from 2010.

CRIME CLEARANCE RATE

The clearance rate for all index crimes reported in 2011 was 15.7%; down from the 2010 rate of 16.1%



ARRESTS FOR INDEX CRIMES

A total of 11,202 people were arrested for index crimes, constituting 12.7% of all arrests made in 2011. The total was down 1.1% from the 11,321 arrests reported in 2010.

DRUG ABUSE ARRESTS

There were 9,920 arrests for drug abuse violations in 2011. This constituted 11.3% of all arrests made in 2011. The total was down 4.6% from the 10,397 arrests reported in 2010.

ALCOHOL RELATED ARRESTS

There were 19,549 alcohol related arrests (DUI, drunkenness, and other liquor law violations) in 2011. These accounted for 22.2% of all arrests for 2011. The total was down 5.7% from the 20,725 alcohol related arrests reported in 2010. Summons or Notice to Appear are counted as arrests.

RATIO OF FULL-TIME LAW ENFORCEMENT EMPLOYEES

In 2011, there were 6,685 full-time sworn law enforcement employees in Kansas. This represents a decrease of 5.1% from 2010. The police employee ratio was 2.8 employees per 1,000 in population. This data includes all agencies reporting data in Kansas.


POPULATION

The estimated population for agencies submitting incident based data in Kansas for 2011 was 2,355,703. This is a 7.8% increase from 2010.

LAW ENFORCEMENT AGENCIES CONTRIBUTING DATA

The total number of law enforcement agencies contributing incident based data in 2011 was 368. There were 369 agencies contributing incident based data in 2010.

Total Index Crimes Reported











Total Aggravated Assault/Battery Reported



- In the past three years the total number of reported aggravated assault/batteries has decreased by 8.9%.











Between 30-40% of the property value reported stolen was later recovered by law enforcement since 2004.

The value of property reported stolen increased 53.1% since 2004.

In the past five years that amount increased by just 0.8%.

In the past three years the increase in value of property stolen was 30.7%.

CLASSIFICATION OF INDEX CRIMES

Index crimes are also referred to as Part I crimes. The following list briefly explains each category and the type of offenses that are reported within each Index classification.

Murder/Voluntary Homicide: The willful killing of another human being. This does not include homicides deemed to be justifiable.

Involuntary/Negligent Homicide: The killing of another human being through the negligence of another.

Forcible Rape: The carnal knowledge of a person, forcibly and / or against that person's will; or where the victim is incapable of giving consent because of his / her temporary or permanent mental or physical incapacity including sexual intercourse with a child under 14 years of age.

Robbery: The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and / or by putting the victim in fear of immediate harm.

Aggravated Assault/Battery: An unlawful attack by one person upon another wherein the offender uses a weapon, or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness. This also includes assault with disease (as in cases when the offender is aware that he / she is infected with a deadly disease and deliberately attempts to inflict the disease by biting, spitting, etc.).

Burglary: The unlawful entry into a building or other structure with the intent to commit a felony, a theft, or a sexual battery.

Larceny/Theft: The unlawful taking, carrying, leading, or riding away of property from the possession, or constructive possession, of another person.

Motor Vehicle Theft: The theft of a motor vehicle. A "motor vehicle" is a self-propelled vehicle that runs on the surface of the land and not on rails.

Arson: To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire, explosion or incendiary device.

Summary Analysis of Index Crimes

INDEX CRIME OFFENSES

The following three graphs illustrate the trends of the 2009, 2010, and 2011 total number of offenses by month. This information is based on the Kansas Crime Index.


The first graph represents the total number of index offenses occurring each month. The other two illustrate breakdowns of violent crimes and non-violent crimes by month.

SUMMARY ANALYSIS

A total of 72,702 index crimes were reported in 2011. With 6,987 offenses, the month of July reflected the highest number of index crimes reported. The month of February showed the lowest number of reported offenses with 4,138 index crimes.


A further breakdown of the 2011 index crime offenses shows June had the greatest number of violent crimes with 759 offenses reported. The lowest number of violent crimes occurred in February with 513 offenses reported. A monthly analysis of the non-violent crimes indicates that July and February showed the highest and lowest number of offenses with monthly totals of 6,251 and 3,625 respectively.

Total Index Crimes By Month





Index Crimes: Crime Clocks



All Index Crimes

- One index crime is reported every 7 minutes and 14 seconds.
- One violent crime is reported every 1 hour 6 minute and 12 seconds.
- One non-violent crime is reported every 8 minutes and 17 seconds.

Violent Crimes

- One murder is reported every 5 days and 19 hours.
- One rape is reported every 10 hours and 25 minutes.
- One robbery is reported every 10 hours 4 minutes and 6 seconds.
- One aggravated assault/battery is reported every 1 hour 25 minutes and 12 seconds.



Property Crimes

- One burglary is reported every 38 minutes and 30 seconds.
- One larceny/theft is reported every 11 minutes and 12 seconds.
- One motor vehicle theft is reported every 2 hours and 4 minutes.
- One arson is reported every 12 hours and 55 minutes and 12 seconds.



These crime clocks should be viewed with care. Being the most aggregate representation of crime data, it is designed to convey the annual crime experience by showing the relative frequency of occurrence of crime incident. This mode of display should not be taken to imply a regularity in the commission of these incidents; rather, it represents the annual ratio of crime to fixed time intervals.

Murder/Voluntary Manslaughter

DEFINITION: The unlawful killing of a human being with malice and aforethought.

Any death due to an argument, fight, assault or commission of a crime. This crime is classified based on the investigation of law enforcement and does not include findings of a prosecutor or court. Involuntary manslaughter, suicide, accidental death and justifiable homicide are not counted in this category.

Attempted murders are classified as Aggravated Assault/Battery and not Murder.

SUMMARY

63 murders were reported by law enforcement in 2011.

Murders accounted for 0.8% of all violent index crimes.

56 murders were cleared by either an arrest or death of the offender with a clearance rate of 90.3%.

59.1% of the homicides committed in 2011 involved the use of firearms. Personal Weapons (Hands, Fists, Feet) consisted of 13.6% and Knives/Cutting Instruments were 10.6%.

Domestic Violence Murder: 20 of the homicides reported in 2011 were flagged as domestic violence.

The most common relationship of the victim to the offender for homicides in 2011 was Unknown at 21.8% followed by Acquaintance at 20.7%. In 65.5% of the cases, the victim knew the offender.

Victim Characteristics:

The most common age group of murder victims in 2011 were 20-29 year olds. They made up 28.6% of all homicides. The 30-39 year old group followed with 20.6%.

Males accounted for 69.8% of homicide victims while females made up 30.2%.

Racial breakdowns for homicide victims were: White 69.8%, Black 27.0%, Asian 3.2%. Hispanic ethnicity was listed in 11.1% of the victims reported.


Suspect Characteristics:

Males accounted for 86.2% of homicide suspects while females made up 10.3%.



Forcible Rape

DEFINITION: The carnal knowledge of a person, forcibly and / or against that person's will; or where the victim is incapable of giving consent because of his / her temporary or permanent mental or physical incapacity including sexual intercourse with a child under 14 years of age.

SUMMARY

841 rapes were reported by law enforcement in 2011.

Rapes accounted for 10.6% of all violent index crimes and 1.2% of all index crimes reported in 2011.

338 rapes were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 41.1%.

87.3% of the rapes committed in 2011 involved the use of Personal Weapons (Hands, Fists, Feet). Knives and firearms represented 1.1% and 1.3% respectively.

Rapes occurred most often in a residence, 79.6%. While 11.3% were in a public area and 7.3% occurred at a business.

The most common relationship of the victim to the offender for rapes in 2011 was Acquaintance at 32.7% followed by Boyfriend/Girlfriend 12.8%. In 81.0% of the cases, the offender was known to the victim.

Victim Characteristics:

The most common age group of rape victims in 2011 were 10-19 year olds. They made up 46.0% of all rapes. The 20-29 year old group followed with 24.4%.

Females accounted for 99.4% of rape victims. (In Kansas, males can be victims of rape if they are under the age of 14).

Racial breakdowns for rape victims were: White 87.0%, Black 11.1%, Unknown 0.8%, Asian 0.6%, Native Indian 0.5%. Hispanic ethnicity was listed in 10.6% of the victims reported.



Robbery

DEFINITION: The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and / or by putting the victim in fear of immediate harm.

SUMMARY

869 robberies were reported by law enforcement in 2011.

Robberies accounted for 10.9% of all violent index crimes and 1.2% of all index crimes.

222 robberies were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 25.6%.

40.9% of the robberies committed in 2011 involved the use of Personal Weapons (Hands, Fists, Feet). Firearms and Knives represented 36.2% and 10.4% respectively.

Robberies are evenly distributed between residence (34.4%), public (29.8%), and business (34.4%).

The property loss attributed to robberies in 2011 amounted to \$1,119,962 which was a decrease of 26.4% from the over \$1.5 million dollars reported in 2010. Cash accounted for 50.3% of total property loss followed by vehicles at 28.9%.

Victim Characteristics:

Victims can be individuals or businesses. By definition, at least one victim in each incident must be an individual.

The most common age group of individual robbery victims in 2011 were 20-29 year olds. They made up 40.6% of all robberies.

Males accounted for 60.4% of individual robbery victims.

Racial breakdowns for robbery victims were: White 77.8%, Black 18.3%, Asian 2.7%, Native Indian 0.7% and Unknown 0.5%. Hispanic ethnicity was reported in 11.9% of the victims reported.



Aggravated Assault/Battery

DEFINITION: An unlawful attack by one person upon another wherein the offender uses a weapon, or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

SUMMARY

6,159 aggravated assaults/battery were reported by law enforcement in 2011.

Aggravated assaults/battery accounted for 77.6% of all violent index crimes and 9.3% of all index crimes.

2,648 aggravated assaults/battery were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 56.9%.

27.2% of the aggravated assaults/battery committed in 2011 involved the use of Personal Weapons (Hands, Fists, Feet). Firearms and Knives represented 22.3% and 18.6% respectively.

Aggravated assaults/battery occurred most often in a residence, 62.0%. While 22.6% were in a public area and 11.0% occurred at a business.

The most common relationship of the victim to the offender for aggravated assaults/battery in 2011 was Stranger at 17.3% followed by Acquaintance at 16.3%. In 68.9% of the cases, the victim knew the offender.

Victim Characteristics:

The most common age group of aggravated assaults/battery victims in 2011 were 20-29 year olds. They made up 30.0% of all robberies.

Males accounted for 59.0% of aggravated assaults/battery victims.

Racial breakdowns for robbery victims were: White 76.4%, Black 20.7%, Asian 1.0%, Native Indian 0.8% and Unknown 1.1%. Hispanic ethnicity was reported in 11.9% of the victims reported.





Burglary

DEFINITION: The unlawful entry into a building or other structure with the intent to commit a felony, a theft, or a sexual battery.

SUMMARY

13,654 burglaries were reported by law enforcement in 2011.

Burglaries accounted for 22.0% of all property index crimes and 19.6% of all index crimes.

1,058 burglaries were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 7.8%.

Burglaries occurred most frequently at a residence (71.3%), followed by business (18.3%).

The property loss attributed to burglaries in 2011 amounted to \$29,467,101 which was an increase of 4.9% from the over \$28.0 million dollars reported in 2010. Electronics accounted for 18.1% of total property loss followed by Jewelry/Precious Metals at 16.5%.

Victim Characteristics:

Victims can be individuals, financial organizations, government, religious organizations or businesses. Individuals made up 83.9%; Businesses 13.3%; Government 1.7%; Others 1.1%.

The most common age group of individual burglary victims in 2011 were 20-29 year olds. They made up 23.9% of all burglaries.

Males accounted for 57.6% of individual burglary victims. Females were 42.1%.

Racial breakdowns for burglary victims were: White 87.5%, Black 9.3%, Asian 1.7%, Native Indian 0.4% and Unknown 1.2%. Hispanic ethnicity was listed in 7.8% of the victims reported.


Suspect Characteristics:

The most common age group of burglary suspects in 2011 were Unknowns at 67.7%. They were followed by 20-29 year olds at 10.8% of all burglary suspects.

Males accounted for 29.6% of burglary suspects, females 6.1% and unknowns made up 64.3%.



Burglary Suspect: Age, Sex, Race








Burglary Offenses: Property Loss Trends



- Copper thefts have been increasing for several years.
- 2011 saw a 322% increase in the value of copper reported stolen during a burglary.
- Since 2009, the increase in reported copper values was 779%.



- An increase in the value of cell phones led to a 73% increase in property value between 2009 and 2010.
- 2011 saw slightly more than 1% increase in value of cell phones stolen in burglaries.



- Values of I-Pod and Mp3 players stolen in burglaries has historically increased each year.
- While 2010 reversed that trend with a 6.2% drop, 2011 rebounded with a 12.9% increase in property value.

Larceny/Theft

DEFINITION: The unlawful taking, carrying, leading, or riding away of property from the possession, or constructive possession, of another person.

SUMMARY

46,876 larcenies were reported by law enforcement in 2011.

Larcenies accounted for 55.2% of all property index crimes and 49.2% of all index crimes.

6,560 larcenies were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 14.0%.

Larcenies occurred most frequently at a residence (41.4%), followed by business (40.8%).

The property loss attributed to larcenies in 2011 amounted to \$39,323,860 which was an increase of 33.1% from the over \$29.0 million dollars reported in 2010. Jewelry/Precious Metals accounted for 27.0% of total property loss followed by Miscellaneous at 14.2%. Copper thefts accounted for 64.0% of jewelry/precious metal thefts.

All Other Theft made up 34.2% of theft types followed by Theft from a Motor Vehicle at 24.0%.

Victim Characteristics:

Victims can be individuals, financial organizations, government, religious organizations or businesses. Individuals made up 70.2%; Businesses 27.2%; Government 1.9%; Others 0.7%.

The most common age group of individual larceny victims in 2011 were 20-29 year olds. They made up 25.1% of all larcenies.

Males accounted for 52.2% of individual larceny victims. Females were 47.4%.

Racial breakdowns for larceny victims were: White 89.4%, Black 7.9%, Asian 1.2%, Native Indian 0.4% and Unknown 1.2%. Hispanic ethnicity was reported in 6.8% of the victims reported.




Larceny Offenses: Property Loss Trending



- Copper thefts have been increasing for several years.
- 2011 saw a 775% increase in the value of copper reported stolen compared to 2010.
- Since 2009, the increase in reported copper values stolen was 3,510%.



- An increase in the value of cell phones led to a 48.2% increase in property value between 2009 and 2011.
- 2011 saw a 29.4% increase in value of cell phones stolen in larcenies.



- Values of I-Pod and Mp3 players stolen in burglaries has historically increased each year.
- 2011 reversed that trend with a 3.0% drop. This is most likely associated with reductions in the cost of these items.

Motor Vehicle Theft

DEFINITION: The theft of a motor vehicle. A “motor vehicle” is a self-propelled vehicle that runs on the surface of the land and not on rails.

SUMMARY

4,240 motor vehicle thefts were reported by law enforcement in 2011 with a value of \$25,547,193. This was an increase of 12.7% in incidents and 11.7% in value from 2010.

Motor vehicle thefts accounted for 6.5% of all property index crimes and 5.8% of all index crimes.

544 motor vehicle thefts were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 12.8%.

Motor vehicle thefts occurred most frequently at a residence (58.0%), followed by business (20.2%).

Automobiles made up 64.3% of the motor vehicle thefts in 2011 followed by motorcycles (9.0%), and Misc/ATV/golf carts (4.6%).

Victim Characteristics:

Victims can be individuals, financial organizations, government, religious organizations or businesses. Individuals made up 90.9%; Businesses 8.5%.

The most common age group of individual motor vehicle theft victims in 2011 were 20-29 year olds. They made up 25.9% of all motor vehicle thefts.

Males accounted for 61.8% of individual motor vehicle theft victims. Females were 37.9%.

Racial breakdowns for motor vehicle theft victims were: White 86.9%, Black 9.9%, Asian 1.8%, Native Indian 0.2% and Unknown 1.0%. Hispanic ethnicity was reported in 11.0% of the victims reported.


Suspect Characteristics:

The most common age group of motor vehicle theft suspects in 2011 were Unknowns at 62.5%. They were followed by 20-29 year olds at 14.4% of all motor vehicle theft suspects.

Males accounted for 32.5% of motor vehicle suspects, females 8.8% and unknowns made up 58.7%.



Motor Vehicle Theft Suspect: Age, Sex, Race







Arson

DEFINITION: To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire, explosion or incendiary device.

SUMMARY

678 arsons were reported by law enforcement in 2011 with a value of \$7,501,826. This was an increase of 2.1% in incidents and 4.8% in value from 2010.

Arsons accounted for 1.0% of all property index crimes and 0.9% of all index crimes.

68 arsons were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 10.0%.

Arsons occurred most frequently at a residence (49.1%), followed by public place (28.7%).

Single Occupancy Dwellings made up 51.1% of the arsons in 2011 followed by Other Structures (19.1%), and Other Dwelling (12.2%).

Structures accounted for 80.2% of the arsons reported in 2011 followed by Vehicles 11.6% and Building Materials 2.8%.

Victim Characteristics:

Victims can be individuals, financial organizations, government, religious organizations or businesses. Individuals made up 74.0%; Businesses 14.7%; Government 9.8%.

The most common age group of individual arson victims in 2011 were 20-29 year olds. They made up 16.5% of arsons.

Males accounted for 59.1% of individual arson victims. Females were 39.3%.

Racial breakdowns for arson victims were: White 83.6%, Black 11.4%, Asian 1.8%, Native Indian 0.4% and Unknown 2.8%. Hispanic ethnicity was reported in 8.3% of the victims reported.





Arson Suspect: Age, Sex, Race







