The KBI was formed in response to requests from the Kansas Bankers' Association, the Kansas Livestock Association, and the Kansas Peace Officers' Association, to create a statewide criminal investigative agency.

### **Investigations Program**

#### Field Investigations Division

The Division provides professional investigative assistance to Kansas law enforcement agencies. Local agencies request KBI assistance when crimes are committed in their jurisdictions that require expert criminal investigative skills. Special agents focus primarily on investigating criminal acts such as homicides, major violent crimes, crimes against children, and government integrity/public corruption cases.

The Child Victims Unit, the Crime Scene Response Team, and the Training Unit are a few of the critical programs under the Field Investigations Division.

#### **Special Operations Division**

The Division provides professional investigative, technical, and tactical services to the Kansas criminal justice community. It deploys a proactive investigative approach to targeting criminal offenders who pose the greatest threat to Kansas citizens. The division works to disrupt and dismantle drug manufacturing and distribution operations, and to reduce the incidence of violent crimes committed by organized criminal groups and repeat offenders.

The Criminal Intelligence Unit, the High Intensity Drug Trafficking Area program, the High Risk Warrant Team and the Missing Persons Clearinghouse are few of the critical programs under the Special Operations Division.



#### **Information Services Division**

The Division supports criminal justice activities at every level through the collection, release and automated exchange of information needed by courts, law enforcement, prosecutors and corrections.



Specific functions and services of the Information Services Division:

- ♦ Operates the Kansas Central Repository of criminal history records
- ♦ Manages the state database of ten-print fingerprint records
- ♦ Maintains the Kansas Offender Registration database and website to facilitate public access to information about persons convicted of certain sex, violent and drug offenses
- ♦ Operates the Kansas Incident Based Reporting System (KIBRS), the statewide database for offense and arrests reports
- ♦ Supports the Kansas Criminal Justice Information System (KCJIS)

#### **KBI Forensic Science Laboratory**

Providing forensic science services to Kansas law enforcement and prosecutors by examining evidence related to criminal cases



## Forensic Science Laboratory Division

**Chemistry:** Analyzes controlled substances and clandestine laboratories

**Biology:** Examines evidence for body fluids and determines the source through DNA analysis

**DNA Databank:** Maintains the DNA profiles and samples collected from arrestees or those convicted of Kansas felonies and certain misdemeanors

Bloodstain Pattern Analysis: Examines the size, shape, distribution, appearance, and location of bloodstains and bloodstain patterns to assist in determining the events or mechanisms that created them

**Toxicology:** Tests biological samples for the presence and amounts of alcohol, drugs, or other toxic compounds

Latent Prints: Recovers, analyzes, compares and evaluates latent prints, footwear and tire tracks; searches unidentified prints in the AFIS database

**Firearm and Toolmark:** Determines whether a bullet, cartridge case or other ammunition component was fired from a particular firearm, and also performs toolmark analysis and serial number restoration

**Trace Evidence:** Performs elemental analysis, primer gunshot residue and fire debris testing

**Digital Evidence:** Examines and analyzes digital information stored or transmitted in binary form on electronic devices such as computers, mobile devices, and external and removable media
