**Tip #1- Journal Entry, Section III, # 2,** Please indicate whether an *Attempt, Conspiracy, or Solicitation* charge is involved by checking the appropriate box and provide the **adjusted** (reduced) severity level for the Grade of Offense (# 3).

**Tip # 2- Journal Entry, Section III, # 5,** *The Presumptive Sentence Range* should reflect the presumptive number of months from the grid box based upon the criminal history of the offender and the severity level of the crime of conviction.
