**Receipts.** KOCH Industries Inc. PAC (KOCHPAC) is registered with the Federal Election Commission (FEC ID C00236489) and files reports on the monthly filing schedule with the Commission. Per advice from the Kansas Ethics Commission, we refer you to the contributions from the PAC listed on our federal reports filed with the FEC.

**Disbursements.** KOCH Industries Inc. PAC (KOCHPAC) made no contributions directly to Kansas non-Federal candidates or committee this year. We sent a mailing to employees of Koch companies on July 17 which resulted in independent expenditures in support of 39 candidates for state office. The portion of the mailing attributable to each candidate was \$8.22. Per advice from your office, the expenditures fall under the requirement to itemize disbursements in excess of \$50.
