KBI identifies remains of woman found last year at Melvern Lake

TOPEKA, Kan. – The Kansas Bureau of Investigation (KBI) and the Osage County Sheriff's Office have identified the remains of a woman who was found last August north of Melvern Lake, in Osage County.

The victim was identified as Anna Marie Baldwin. She was 40 years old at the time she was discovered. Baldwin lived in the Topeka area. She was 5 ft. 6 in. tall, and weighed approximately 120 lbs. She had brown hair, hazel eyes, and at times wore gold framed glasses.

The KBI believes Baldwin was killed sometime between April and July 2017. They ask anyone who knew Baldwin in late 2016 or in 2017, or who has information related to this crime, to contact them at 1-800-KS-CRIME. Callers may remain anonymous. KBI requests assistance in identifying remains of woman found at Melvern Lake

OSAGE COUNTY – The Kansas Bureau of Investigation (KBI) and the Osage County Sheriff's Office have requested the public's assistance in identifying the remains of a woman found Aug. 25 at Melvern Lake. It is believed the woman was the victim of a homicide.

Forensic anthropology experts from the Washburn University Anthropology Department assisted law enforcement in studying the remains. They reported that the deceased individual is female, and likely Hispanic, however, White cannot be ruled out. They provided a likely age range between 35 and 50 years of age, but also offered a broader range of 30 to 65 years of age. She was believed to have been 5-foot-2 inches to 5-foot-8 inches, but could potentially also be between 5-foot-1 inches to 5-foot-9 inches. The report suggested that she was killed and has

been at the scene since sometime between late Fall 2016 and July 2017, with a narrower estimate of April 2017 to July 2017.

KBI agents and Osage County Sheriff's deputies are also releasing information about the woman's clothing and jewelry to hopefully aid in identifying the victim. Her shirt size was small, and the brand "No Boundaries." Her pants size was 32x30, and the brand "Helix." Her bra size was 44 and the brand "Fruit of the Loom." She was wearing several items of jewelry which include: a silver ring that spells "love" in cursive writing, a gold or bronze ring with a red stone, a silver bangle bracelet, and gold or bronze framed eyeglasses. Unidentified human remains found at Melvern Lake

OSAGE COUNTY – The Kansas Bureau of Investigation (KBI) and the Osage County Sheriff's Office are investigating after human skeletal remains were found Friday night at Melvern Lake.

At approximately 5:30 p.m. Friday, Aug. 25, a park ranger from the U.S. Army Corps of Engineers discovered skeletal remains during a routine check on the north side of Melvern Lake. The discovery was made near an area of the lake called Turkey Point Waterfront Day Use. The park ranger contacted the Osage County Sheriff's Office, who then requested KBI assistance Friday at around 6:20 p.m. KBI agents and the Crime Scene Response Team responded to help investigate.

Further forensic examination needs to be performed on the remains before the person's sex, race, age, and cause of death can be determined. Forensic anthropology experts from the Washburn University Anthropology Department are also assisting with this investigation.

This investigation is ongoing. No further information will be released at this time.
